Exhibit Rules

1. Submit your completed application form, with exhibit data as shown below, to the registration desk by noon on Saturday. *Exhibit cases cannot be guaranteed without advance registration.* (Attention: Eric Holcomb, Exhibit Chairman, phone 253-850-2996.) Your exhibit(s) must be in place in the exhibit area by noon Saturday. Exhibits should be removed between 3:00 PM and 4:00 PM on Sunday.
2. Exhibit material must be the personal property of the exhibitor. Buying, selling or trading in the exhibit area is not allowed, and the exhibit itself may not be used for advertising purposes.
3. Judging of competitive displays will begin at about 2:00 PM on Saturday. There will be a 15-minute period to appeal the judging results. People's Choice voting will be open until 2:00 PM on Sunday.
4. There is a limit of three exhibits per person, seven cases per person, and one entry per category.
5. *To be eligible for an award in a competitive exhibit category, the exhibit must receive at least 50 out of 100 possible judging points, based on an average score from two or more judges. Exhibits scoring less than 75 points may not be eligible for 1st place awards.* At the discretion of the judges, exhibits that won 1st place or best of show awards at past BECC coin shows may be disqualified from receiving awards this year, unless the exhibits have been substantially modified or improved.
6. Only Boeing Employees' Coin Club members are eligible for the Virgil Simpson Award.
