2. **Per Kent City Code, NO FIREARMS are permitted in the building. (24-Hour SECURITY PROVIDED) NO firearms, large knives, or other weapons may be displayed or offered for sale.**
3. Applicant further understands and agrees to abide by the following rules:
  - a. Dealer hours will be 8 AM to 5 PM Saturday, and 9 AM to 4 PM Sunday. Public hours begin at 10 AM. **No Dealer-to-Dealer activity prior to 9:00 AM. The room must be vacated by 5 PM Sunday.**
  - b. Payment in full for all tables rented is due by **December 2, 2019.**
  - c. Tables are 2.5 feet wide by 6 feet long. Two chairs provided for each table and for your arrangement.
  - d. The tables are occupied solely by Applicant and shall not be subleased. The location of the tables is at the sole discretion of the Boeing Employees' Coin Club.
  - e. Only Applicant or Applicant's agent(s) may act for Applicant at the show.
  - f. Applicant must own or have on consignment all merchandise on the Applicant's table(s).
  - g. Activity at the table is primarily restricted to transactions (e.g., buying, selling, trading, appraising) involving numismatic material and related items. Other business activities are not allowed.
  - h. Applicant is solely responsible for collecting and paying all state and local taxes.
  - i. Applicant is solely responsible for obtaining any required licenses.
  - j. The Boeing Company and/or the Boeing Employees' Coin Club and/or Kent Commons have the right to deny or discontinue Applicant's participation at any time for any reason.
  - k. Applicant agrees to follow all Kent Commons' rules and regulations, including those pertaining to loading/unloading, not attaching items to walls, and using protective floor coverings if required.
  - l. **Applicant agrees to pay for damages to property caused by the Applicant or Applicant's agent(s).**
